HOW TO SIGN UP FOR OPEN DOORS

Simply fill out the registration form online or on the back of this brochure, and submit to your local branch.

To process your application, we will need a copy of your **current Federal Tax Return** for all adults in the household to verify household income. If you did not file taxes, we ask that you provide the following (as applies):

- Copy of last two pay stubs
- Copy of social security or disability checks (or copy of bank statement showing amount of automatic monthly deposit).
- Copy of retirement/pension income
- Copy of child support
- Copy of state assistance, including food stamps
- Copy of unemployment checks

The YMCA requires that individuals reapply when their membership expires, or when requested, to keep the information on their application updated. The ability of the YMCA to respond to requests for assistance is dependent upon the success of fundraising projects and the current operating financial situation. Financial assistance rarely covers 100% of the total membership or program fee. Your fees are subject to increase when you reapply. If you do not reapply when requested, your enrollment may be terminated.
